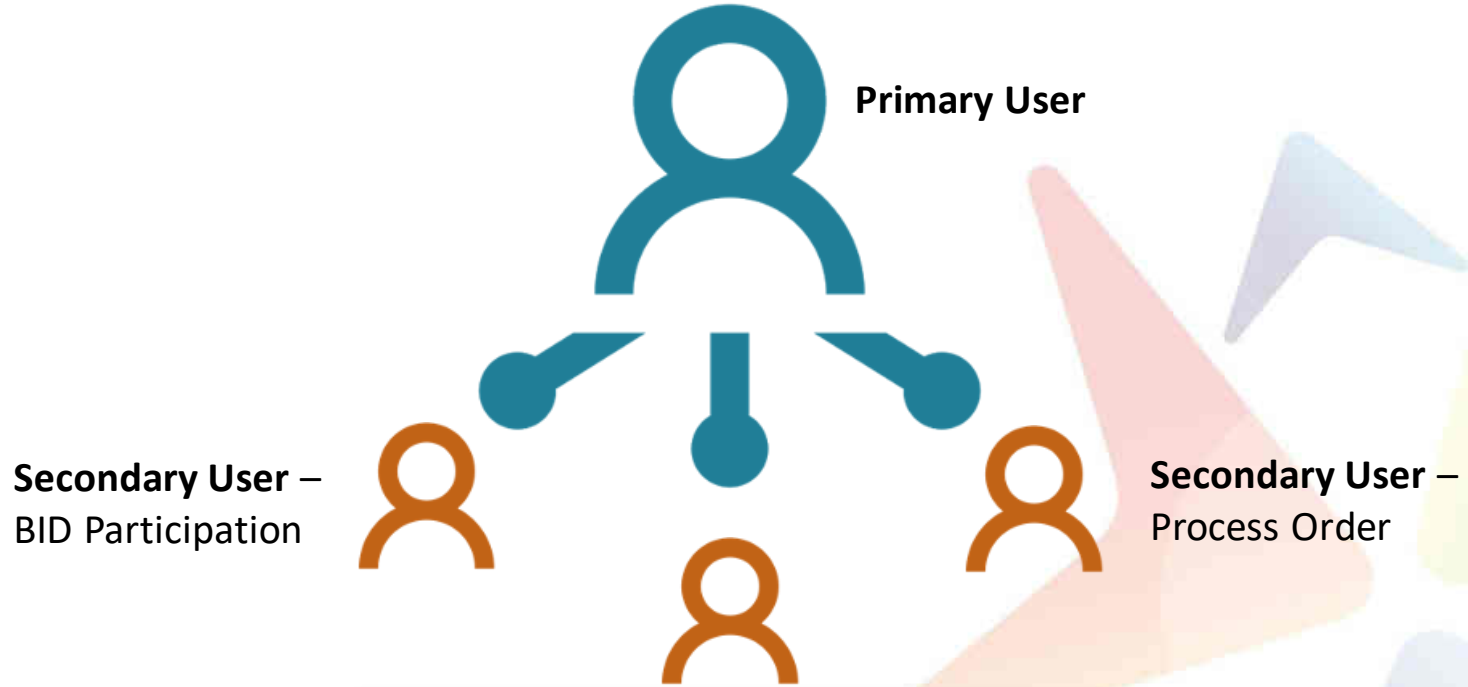

# Public Procurement Policy for MSEs



Public Procurement Policy for MSEs Order, 2012 notified under section 11 of MSMED Act 2006.

Policy mandates **25%** of procurements of **goods and services** from MSEs

Includes **4%** from MSEs **owned by SC/ST**

✓ **3%** from MSEs **owned by women** out of total annual procurements

## Benefits extended to MSEs

Tender sets free of cost

Exemption from Earnest Money (EMD).

358 items exclusively reserved for MSEs.

Purchase Preference for minimum 25% qty. to MSEs within L1+15% on matching L1.

# Current Functionalities deployed in GeM for PPP- MSEs



1. API Integration with Udyog Adhaar:  
All sellers claiming to be MSE are required to validate their MSE status through Udyog Adhaar
  
2. The MSEs are exempted from EMD, if
  - I. MSE as **manufacturer of the Primary Product Category**, OR
  - II. **Service Provider of the Primary Service Category** and give specific confirmation to this effect at the time of bid submission ***and whose credentials are validated online through Udyog Adhaar and through uploaded supporting documents*** .
  - III. MSE **registered with NSIC and DIC for the Primary Product Category** ***and whose credentials are validated through NSIC /DIC database and through uploaded supporting documents.***
  
3. Buyer has been provided with Option to Exempt the MSEs from;
  - 1- **Turn Over** and
  - 2- **Past Experience criteria** at the time of creation of Bid as provided for in PPP - MSE Order.
  
4. Further, suitable ATC clauses are already enabled for ensuring compliance of PPP - MSE orders.

# Clauses provided in ATC library in GeM Bidding Module for effective implementation of all provisions of PPP MSEs Order for Central/State Govt :



- ❖ Purchase preference will be given to MSEs **as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order 2012 dated 23.03.2012 issued by Ministry of Micro Small and Medium Enterprises** and its subsequent Orders/Notifications issued by concerned Ministry.
- ❖ Purchase preference will be given to MSEs as Micro and Small Enterprises from the **State of Bid inviting Authority** whose credentials are validated online through Udyog Adhaar for that product category.
- ❖ If the bidder wants to avail the Purchase preference **the bidder must be the manufacturer of the offered product in case of bid for supply of goods.**
- ❖ In respect of bid for Services **the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid** in respect of the offered product or service.
- ❖ **If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% of margin of purchase preference/price band defined in relevant policy such Seller shall be given opportunity to match L-1 price and contract will be awarded for percentage of {required Percentage}% of total value.**
- ❖ Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises.

# Order Splitting in terms of provisions of PPP MSEs and PPP-MII Orders



1. Bidder is required to **upload the necessary documents to prove their eligibility** for particular category of benefit.
2. The Buyer evaluates the documents and indicates whether the bidder is eligible for EMD exemption and / or Purchase preference as an MSE .
3. In case of Purchase preference for MSE, Buyer get on-line option to ask the MSE within 15% of L-1 to match L-1 price and to generate split orders.
