- It provides the tools of e-Bidding, Reverse Auction and Direct Procurement to facilitate Government users achieve the best value for their money.

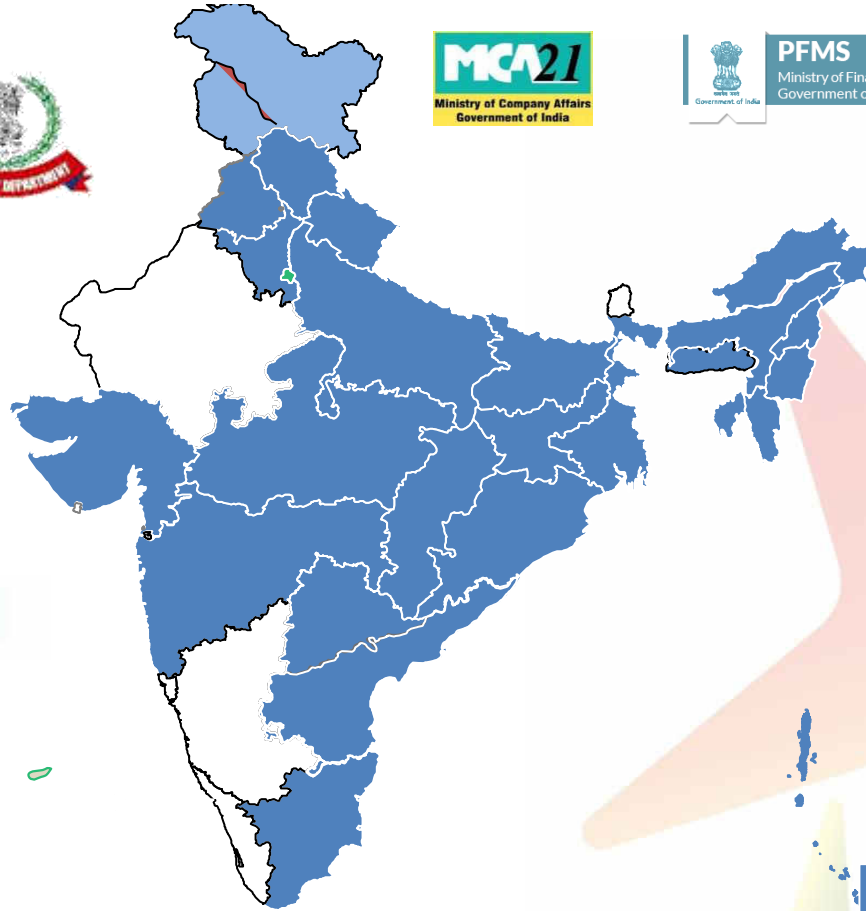

## Quadrant 3:

- Product offers in categories under this group can be from OEMs and/or their Authorized Resellers concurrently.
- In case OEM has not created Product Catalogue, Authorized Resellers of OEMs are also permitted to do the same

## Quadrant 4:

- Product and/or Offers in categories under this group can be from OEMs and/or Resellers.
- In case OEM has created Product Catalogue, then their catalogue will be used exclusively for pairing by all Resellers without any requirement of further endorsement of any kind by the OEM



# Ratings for Sellers

## Seller Rating

- A strong vendor rating system will reward good performance of sellers by giving them opportunity for more business
- Sellers will also be able to improve upon their ratings by focusing on specific areas
- Fake/Inactive sellers will be weeded out, hence ensuring only genuine sellers get to do business with government.
- Parameters for the Seller Rating :
  1. Coverage
  2. Timely Delivery
  3. Quality of Order Fulfillment
  4. Reliability

- Vendor Assessment is a contributing parameter to arrive at the Seller Rating displayed on the GeM Marketplace.
- The Vendor Assessment of the applicant will be based on authentication of vendor profile, financial capacity and technical details of the items to be offered on GeM as per the prescribed format.

# Process for Onboarding



## Outlined process for these categories:-

1. Invite Sellers to register on GeM
2. Request for VA Exemption through QCI via online. Select UCC and submit the certificate online. QCI to approve the registered vendors - ***VA Exemption and approval on the basis of UCC Certificate.***
3. OEM Panel gets enabled and seller to apply for the brand with TM certificate/ NSIC certificate/ UAM/ OEM Authorization Certificate / BIS License wherever applicable.
4. Only for Q1 category “Personal Protection Equipment (PPE) Body Coverall for Covid-19”, if seller has no TM Certificate the company name will be considered as brand name on the basis if UCC certificate submitted.
5. Once their brand request submitted, it will get approved in 24-48 hrs (only COVID categories)
6. Once brand approved the seller can upload products through Dashboard and it will get approved as per TAT 24-48 hrs (only COVID categories).
7. Seller has to publish the product on the marketplace as per category specifications.

## **For Primary User Registration:**

- ✓ Aadhaar Number / Virtual ID/ PAN of the User.
- ✓ Mobile number linked with Aadhaar/Mobile number in case of PAN
- ✓ Active Email id
- ✓ Documents as per Constitution type such as CIN, PAN, DIPP, UAM, ITR details to Complete profile.
- ✓ Address details (Registered address as per ITR)
- ✓ Bank account details



## **Secondary User Registration:**

- ✓ Aadhaar number
- ✓ Mobile number should be linked with Aadhaar
- ✓ Active Email ID.

# Pre-requisite For Brand & Product Approval



## **Documents Required for Brand approval:**

- ✓ Company Registration Certificate
- ✓ Trademark Certificate or Application of Trademark Certificate
- ✓ Vendor Assessment Report
- ✓ BIS / NSIC / MSME / UCC Registration Certificate, where applicable
- ✓ FSSAI License, where applicable
- ✓ SKU & HSN (to be entered in the system)
- ✓ OEM Authorisation Certification (in case of Reseller)
- ✓ Company Website URL (should be functional)



## **Documents Required for Product upload:**

- ✓ Certification in case of product certified by any agency
- ✓ For Price Reference - Product Brochure / OEM Website link / Purchase Order
- ✓ For Product Model – Product Brochure / OEM Website link

## **Others**

- ✓ Experience Certificate with Government & Turnover Certificate in case demanded by Buyer



- Registration(Primary Seller) on GeM should be done by an authorized person of the organization (Director of the organization or a Key Person or authorized signatory of ITR).
- Primary seller have an option to create secondary seller's to assign roles like Bid Participation, Creation of Catalog and Order Fulfillment.
- For MSE , UAM ( Udhyog Aadhaar Memorandum) and aadhar/mobile number linked with the same is required.
- For Start Up, DIPP (Department of Industrial Policy and promotion) number and mobile number linked with the same is required.
- No separate registration required for Seller and Service provider.



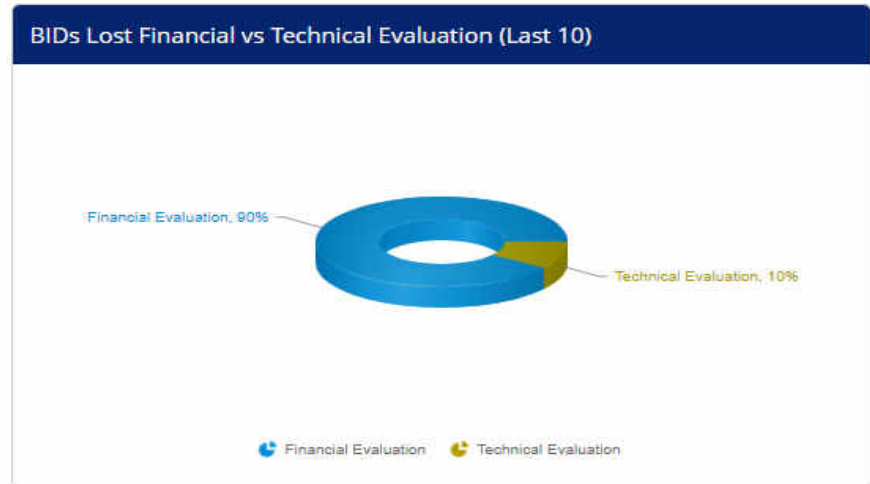

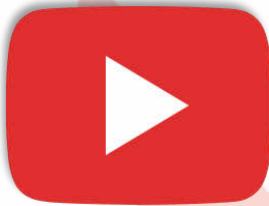
